#### 2. APOLOGIES

Apologies were received from Bill Purvis and Derek Purvis.

#### 3. MINUTES OF THE MEETING OF THE SOCIETY BOARD HELD

**05/12/09, DECISION:** To approve as a correct record the minutes of the meeting of the Society Board held on 5/12/09. There were no matters arising.

#### 4. MEMBERSHIP SECRETARIES REPORT

In his absence, due to the bad weather, Bill e-mailed a report through: For your information membership has dropped by a further 2 to 216 and we currently have two members two payment in arrears who are likely to be dropped next month – however, no one else has missed payments this month.

**ACTION** At the first meeting post AGM we will need to plan for Membership retention/ recruitment.

#### 5. TREASURERS REPORT

We have a balance of £3,079.09

We have to date paid 6 months of the £300 per month promised to the Club (total £1,800).

**ACTION** It was decided to pay £500 extra to help offset some of the loss of income due to match postponements in the bad weather, and publicise this on the website.

It was also decided to talk to other Trusts to see where they have their audits done, and the costings, as any savings made can help us contribute more to the club.

An agenda item for a future meeting would have to be website and domain costs, as a tightening of this could realise savings.  
Quotes would from now on be obtained from 3 local printers to get best price for any work done. Gordon will circulate a cash flow analysis which he has produced at the first meeting of the new Board.

## **6. AGM**

The digital paper work has been converted and updated. Some parts of the papers would come out, to be available on request to keep paper and postage costs down.

The effects of the bad weather on matches and work on the AGM has meant that a revised date of Saturday 13<sup>th</sup> February has been set.

## **7. SUPPORTERS CLUB REPORT.**
